On Thursday, July 4th we will be celebrating the 29th Annual “Oceanfest at Long Branch”! Oceanfest is a family event that starts at 10:00 a.m. and culminates at 9:30 p.m. with a world-class fireworks display.

Oceanfest is a combination of music, entertainment, quality arts & crafts, fabulous food, games, professional sand sculptures and just plain fun. It all takes place on the Oceanfront Promenade in front of the Ocean Place Resort & Spa and spans more than one-half mile of boardwalk and the adjoining streets.

Oceanfest has consistently drawn huge crowds every year from all over the county and metropolitan area. As in the past, crowds of over 200,000 are expected.

Attached is your vendor application and instructions. Oceanfest is a rain or shine event. Please read the application carefully before signing. **Please be sure to include your vehicle license plate number on your application**, this information will expedite your entry that day into the event. If you are using multiple vehicles, please include all plate numbers. If you are renting a vehicle, please specify on the application. **PLEASE NOTE GENERATORS ARE NOT PERMITTED.**

OCEANFEST ARTS & CRAFT VENDOR AGREEMENT

*******PLEASE KEEP THIS AGREEMENT FOR YOUR RECORDS*******

By signing the application the applicant agrees to the following Rules & Regulations governing exhibitors and vendors at Oceanfest 2019.

HOURS OF OPERATION: All craft vending areas shall be set up as follows: Set up between the hours of 7:00 – 9:30 a.m. Craft spaces must remain set up until 5:00 p.m. or until the event closes at 9:30 p.m. Early departure must be made between the hours of 5:00 and 6:00 p.m.

VENDOR SPACES: Single spaces are 10' x 10'; double spaces are 20' x 10' and are outdoors on the oceanfront. Please be sure tents are secured properly, since wind can be strong along the oceanfront.

GENERAL RESTRICTIONS

All craft vendors shall restrict their sales, placement of signs, posters, etc. to their specific space assignment. Craft vendor space will be limited to **handcrafted items only** unless otherwise approved by the Oceanfest Committee.

*****Anyone selling items not approved by the Oceanfest Committee will be asked to leave. This also will apply to anyone selling fireworks**.***

No alcoholic beverages or controlled substances shall be sold, consumed or possessed by any vendor or their agents and employees.

REFUNDS OF PAYMENTS AND CANCELLATIONS: Refunds of any payment made for space by any vendor who cancels his/her reservation shall be made by JUNE 3, 2019. After this date **the Greater Long Branch Chamber of Commerce will make NO refunds.**

Any craft vendor who FAILS to set up for the event by 10:00 a.m. SHALL FORFEIT the space assigned and the Greater Long Branch Chamber of Commerce shall give NO REFUND of payment.

CONDITIONS

The craft vendor is subject at all times to inspection by the City of Long Branch and the State of N. J. to the proper and legal conduct of the business for which the privilege is granted. Sales Tax certificates should be posted and visible at all times.

Oceanfest is a rain or shine event. The craft vendor assumes all responsibility for any damage resulting from the operation thereof is liable for any violation of law and has no claim on the City of Long Branch and the Greater Long Branch Chamber of Commerce. The City of Long Branch and the Greater Long Branch assumes no liability for theft, lightning, rain, wind, sand, tidal damage, or acts of God.

It is understood and agreed that the City of Long Branch, the Greater Long Branch Chamber of Commerce, and their agents and employees shall be held harmless from liability arising from the use of vending space. **It is further agreed that said spaces will be used solely by the applicant/organization and that no other group, organization or individual be permitted to utilize said spaces. No privilege for space shall be sublet, sold, assigned, or transferred by the holders thereof.**
